

**ANNUAL INFORMATION UPDATE KARDAN N.V. (the “Company”)

CHAPTER B - ISRAEL

Under the Israeli rules and regulations similar filings and notifications are required as under the Dutch rules and regulations.

Once a year a mini prospectus is filed (according to a mandatory format) at the end of March, which is called "Barnea report".
